I. Welcome and introductions

Attendees introduced themselves. Ranjit explained how the original BPAC came about and differences between how it was set up then and how it's set up now. He discussed the contents of several policy documents BPAC had written, including NJ Title 39: Analysis and Recommendations for Bicycle Provisions and Evaluation of New Jersey Statutes Affecting Bicycling and Walking. The former was not finalized; could be used as a starting point for further analysis and recommendations for changes to Title 39.

II. Why are we here? Purpose/mission of group

The following comments were made with regards to the purpose/mission of the legislative and policy subcommittee:

- Educate legislators and public about laws pros and cons of recommendations
- Change mentalities to focus on pedestrians and bicyclists
- Advise DOT (and potentially other state organizations)
- Discussed whether or not the members of this subcommittee are advocates and if they can provide recommendations - concerns from MVC (could abstain, be only in an advisory role)
- Separate subcommittee members and advisory-only members, so that we can still keep our ability to make recommendations and to also have government entities involved
- Since Title 39 is largely law enforcement, the Attorneys General office could be involved
- Understand the baseline views of the various government agencies related to transportation policies
- Be an unbiased resource on legislative and policy affecting New Jersey's bicycle and pedestrian environment

Attendees agreed that the subcommittee's purpose should be to advise and educate:

- Who: NJDOT, New Jersey legislators, other state agencies
- What: requests from advisees (reactive) and new projects initiated from within the subcommittee (proactive)
- When: depends of needs of advisees
- How: through products, meetings, testimony, presentations, workshops, or conferences
- Why: to improve New Jersey's bicycle/pedestrian environment and to provide clarity on the laws and policies that govern biking and walking in New Jersey

III. How do we make this group work?

A. What level of effort is reasonable?

Attendees acknowledged that there is limited time to produce quality products due to the volunteer nature of the subcommittee, and discussed the potential of accessing further resources from NJDOT.

B. Meetings (in person/call)

All expressed preference for face-to-face meetings. Seven in-person meetings will be held each year.
