 - Lots going on at NJDOT regarding Complete Streets:
 - Increasing priority at FHWA
 - Ongoing work to implement the Strategic Highway Safety Plan, can reach out for more information

 - Review and audit of roadways for bike/ped accommodations
 - Member of SHSP task force
- Reba Oduro NJDOT
 - Engineer with Bureau of Safety, Bicycle and Pedestrian Programs
 - Working on Complete Streets implementation on state projects
 - Researching best practices for implementing a count program in NJ
 - Focusing on pedestrians and bicyclists (all non-motorized transport, including e-scooters) and looking at best practices in other states
 - Working on last deliverable technical memo on technologies to collect counts
 - Goal is a best-practices study to see what other states are doing and what could work in NJ.
 - Eventual goal is to create an implementation plan
 - DVRPC very interested in connecting on this project, as they are also working on bike/ped counts

- Working with bike/ped and review of accommodations, including traffic signals, roundabouts, etc.
- Jeevanjot Singh NJDOT
 - Observing a shift in awareness from the public recently, they seem more supportive of projects like roundabouts
 - The Highway Safety Improvement Program (HSIP) has 50/50 funding structure.
 Planning comes off the top, the remainder is split between NJDOT capital projects and local projects
 - Denise Nickel: Crash data has been used extensively in the planning process. We also are applying for Local Safety Program (LSP) support for some of these corridors. We also are aware of a lack of local applications for safety funds.
- Mike Dannemiller Middlesex County
 - Planning to submit a lot of projects to NJDOT soon!
- Michael Popovech Monmouth County
- Byron Nicholas Hudson County
 - Hudson County is in the process of submitting an application for a couple of roundabouts on JFK Blvd East in James Braddock Park.
 - County has just received concept designs from consultants assisting with the application.
 - NJTPA has been very supportive of including roundabouts as a safety countermeasure in LSP projects.
- Adam Bradford Somerset County
 - Transit-oriented/walkability study being planned with NJTPA
 - Charging stations in Somerset, all work being done in-house
- Karen Alexander VTC
 - Pinelands project looking at access to outdoor spaces, mapping of accessibility within their complex
 - Trenton Health Team looking at making their website more accessible
 - Building an inclusive garden
- It was noted that the subcommittee time was spent on introductions and planning but not design discussion.
 - Chair responded that depending on the interest from the subcommittee, some sessions are more discussive and connective to resources, some are more technical.
- NJDOT noted that CS guidance from FHWA includes emphasis on arterials, which might be a worthwhile topic for the subcommittee in the future.
