The New Jersey Department of Transportation (NJDOT) is pleased to announce that the application period is now open for our 2022 Safe Routes to School (SRTS) program. The deadline to apply is October 14, 2021. Program requirements and supporting documents can be found at this <u>website link</u>.

The NJDOT has offered free online training sessions providing participants with information about applying for the SRTS Program. Topics covered in this online training included: Overview of Federal Aid programs and the Safe Routes to School Program; Detailed Review of the Safe Routes to School Grant Application; Grant Application Process; Grant Resources, Tips & Strategies; and Q&A with NJDOT Local Aid Staff.

Lastly, the NJDOT is offering One-on-One Application Meetings to provide direct assistance to applicants in developing better and stronger applications. One on One meetings are not a mandatory requirement to apply for funding. Meetings will be held from June 22, 2021 through September 24, 2021. Evaluating the Pedestrian Hybrid Beacon's Effectiveness:
A Case Study in New Jersey

In August 2021, the New Jersey Department of Transportation (NJDOT) Technology Transfer program featured a research spotlight article, discussing the effectiveness of Pedestrian Hybrid Beacons (PHBs). The article summarized findings from the NJDOT-funded 2020 New Jersey Bicycle and Pedestrian Resource Center research on *Evaluating the Pedestrian Hybrid Beacon's Effectiveness: A Case Study in New Jersey*.

The research included findings from case studies across the Country, analyzed pedestrian and driver behavior around three PHB locations in New Jersey, and surveyed the level of public awareness about PHBs in the State through an online survey.


