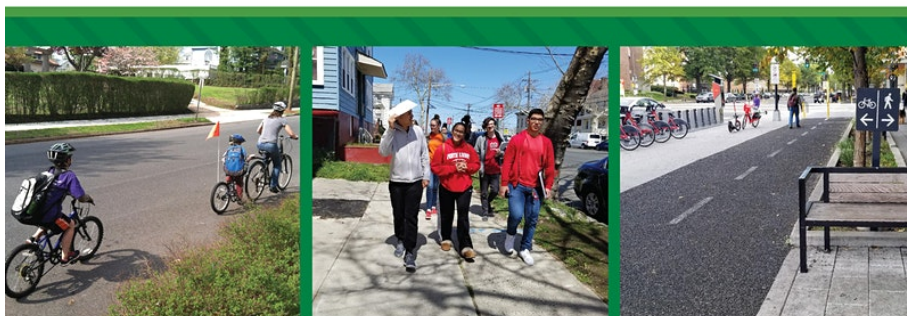
## Celebrate the Joy of Walking on this International Walk to School Day!

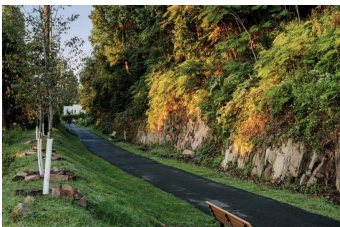

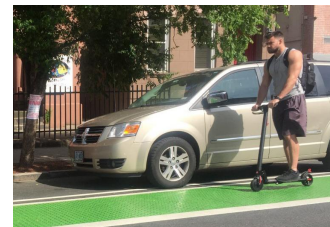

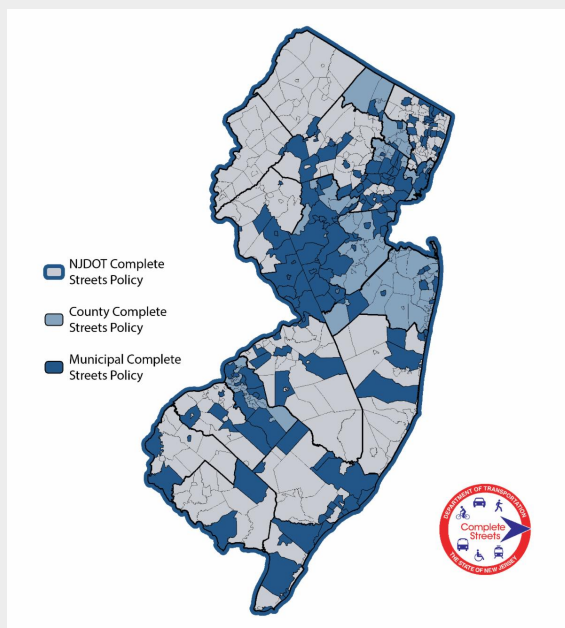
