NJTPA Complete Streets Technical Assistance Program Applications Opening on December 6, 2021 Register for the Informational Webinars Now!

Through North Jersey Transportation Planning Authority's (NJTPA) Complete Streets Technical Assistance Program, Sustainable Jersey is collaborating with the Alan M. Voorhees Transportation Center (VTC) at Rutgers University and is seeking applications from municipalities to receive free technical assistance services for a specific project related to advancing a complete streets initiative in their communities. The program is made possible through NJTPA's federal funding from the U.S. Department of Transportation.

Registration is also open for **two free webinars** that will assist municipalities in identifying projects and applying for technical assistance to support their needs. 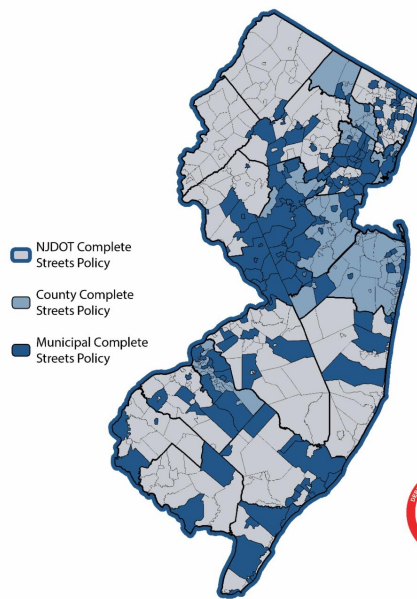
