Title 39: New Perspectives One-Day Class for Law Enforcement Officers

These Guys is offering a one-day class designed to show patrol officers traffic law from the perspective of bicyclists and pedestrians. Topics covered include Title 39 for bicyclists and pedestrians, roadway design, education solutions, and bicycle crash investigation.

The Federal Highway Administration (FHWA) is collaborating with State, local, Tribal and industry partners and the public to build for the future by identifying proven, market-ready but underutilized processes or technologies in the next round of Every Day Counts (EDC). The EDC program aims to deliver transportation projects more efficiently and effectively, enhance safety for all users, support a sustainable and resilient infrastructure, and incorporate equity in project planning and delivery. In addition, FHWA seeks feedback on user experiences with high-value innovations described as **"innovations of interest"** and tentatively identified for accelerated deployment. Responses are being accepted until **April 11, 2022**.

Recent Updates to DVRPC's Bike Level of Traffic Stress (LTS) and Connectivity Analysis

DVRPC's Bike Level of Traffic Stress (LTS) and Connectivity Analysis is a regional screening tool developed to help identify and rank roads where bicycle facility improvements would have the greatest local and regional connectivity benefit to the low-stress bicycle network. The analysis has recently been updated to include additional data such as gaps that impact Title 6 and EJ communities as well as a new story map.



NJTPA's FY 2022-2025 Transportation Improvement Program Available Online

NJTPA's current [Transportation Improvement Program \(TIP\) for FY 2022-2025](#) is now available online. The four-year fiscally constrained listing of projects and programs was approved and adopted by the NJTPA Board on September 13, 2021 and incorporates the performance benchmarks in accordance with the MAP-21/FAST Act Performance-Based planning requirements.

Check out Trenton’s Complete Streets Design Handbook

Released in September 2021, Trenton's Complete Streets Design Handbook provides specific and general recommendations for building Complete Streets in Trenton based on existing roadway features and design best practices. The handbook categorizes streets by type and illustrates potential improvements for pedestrians, bicyclists, transit users, and motorists for each street type.

This is a great resource for those seeking to identify ways to apply Complete Streets design principles in their communities, with the goal of implementing projects that serve the needs of all road users.


