

**RESOLUTION 2013-0730/1A**

**ESTABLISHING AND ADOPTING A COMPLETE STREETS POLICY FOR THE  
BOROUGH OF POINT PLEASANT BEACH**

**WHEREAS** the Borough of Point Pleasant Beach is committed to creating street corridors that safely accommodate all road users of all abilities; and

**WHEREAS** the New Jersey Department of Transportation's Complete Streets policy states, "A Complete Street is defined as a means to provide safe access for all users by designing and operating a comprehensive, integrated, connected multi-modal network of transportation options."; and

**WHEREAS** the Mayor and Council of the Borough of Point Pleasant Beach support the Complete Streets initiative and wish to implement a Complete Streets policy through the planning, design, construction, maintenance and operation of new and retrofit transportation facilities, enabling safe access and mobility of pedestrians, bicyclists, transit users of all ages and abilities.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Point Pleasant Beach, County of Ocean, State of New Jersey, that all public street projects, both new construction and reconstruction (excluding maintenance) undertaken by the Borough of Point Pleasant Beach shall be designed and constructed as "complete streets" whenever feasible to do so in order to safely accommodate travel by pedestrians, bicyclists, public transit, and motorized vehicles and their passengers, with special priority given to bicyclist and pedestrian safety subject to the following conditions:

1. Pedestrian and bicycle facilities shall not be required where they are prohibited by law.
2. Public transit facilities shall not be required on streets not serving as transit routes and the desirability of transit facilities will be determined on a project specific basis.

**BE IT FURTHER RESOLVED** that a certified copy of this resolution shall be sent to the Point Pleasant Beach Planning Board, the Borough Engineer, Ocean County Board of Chosen Freeholders, Ocean County Engineering, State of New Jersey Department of Transportation and the New Jersey Bicycle and Pedestrian Resource Center at Rutgers University.
