

Tony Garcia is a nationally recognized architect, writer, speaker and advocate in the field of transit, pedestrian and bicycle infrastructure. Tony's work has appeared in numerous publications. Tony is a coauthor of the globally acclaimed series *Tactical Urbanism: Short-Term Action, Long-Term Change Vol. 2*, and together with Mike Lydon is the recipient of the 2017 Seaside Prize and co-author of *Tactical Urbanism*, published by Island Press. He is the former Chairman of the Green Mobility Network, the largest bicycle pedestrian advocacy organization in South Florida, and co-founded the Ludlam Trail project, which will result in the addition of over 50 acres of new park space in Miami-Dade County. He was the Publisher and Managing Editor of *TransitMiami.com*, an award winning web journal dedicated to public participation and discourse in south Florida. Tony holds a B.A. in Architecture and Urban Design from New York University and a Masters in Architecture from the University of Miami.

Janna Chernetz

Director, New Jersey Policy, Tri-State Transportation Campaign, NYC

Janna Chernetz focuses on issues related to sustainable funding of the New Jersey Transportation Trust Fund and the state budget, pedestrian and bicycle safety, and enhancing economic development through the connection of land use and transportation. Janna led a successful campaign to include bike accommodations on the entire 12.5 mile NJDOT rebuild of Route 35 in Ocean County and played an integral role in the creation of NJDOT's Pedestrian Safety Action Plan and currently serves as an Executive Council member of New Jersey's Bicycle and Pedestrian Advisory Committee. Janna received her B.A. in Political Science from Rutgers University, and her Juris Doctor from Vermont Law School where she was an Environmental Dean's Fellow. Janna was admitted to practice law in New Jersey in 2002 and is currently a registered Governmental Affairs Agent.



John Boyle

Research Director, Bicycle Coalition of Greater Philadelphia

John Boyle has been a commuting cyclist for more than 20 years. In 1994 he began working as a volunteer for the Bicycle Coalition of the Delaware Valley after attending a volunteer night, and later served as a board member from 1997-98. In 1999 John left Philadelphia for Charlottesville, VA, where he helped establish the Alliance for Community Choice in Transportation (ACCT), a bicycle and walking advocacy group. John joined the Bicycle Coalition as staff in 2001, first as project manager for the Regional Bicycle Map and the Philadelphia School District's Bicycle Education and Enhancement (BEEP) Program, then serving as Advocacy Director. He now lives in Edgewater Park, NJ with his wife and two children, and commutes by bike and train via the River Line and Ben Franklin Bridge.

Kandyce Perry manages New Jersey Future's Mainstreaming Green Infrastructure program. She also assists in coordinating the Green Infrastructure Committee of the Jersey Water Works collaborative, which is working to upgrade New Jersey's water infrastructure with cost-effective, sustainable solutions, and Trenton's Municipal Action Team for which she does community engagement and outreach on green infrastructure. Richard T. Hammer was confirmed by the New Jersey Senate as Commissioner on August 1, 2016. He was appointed Acting Commissioner on October 30, 2015. Prior to his appointment, Commissioner Hammer led the Department's Capital Program Management (CPM) organization as Assistant Commissioner. He began his career with NJDOT in May of 1982 upon graduation from Rutgers University with a B.S. in Civil Engineering. His lengthy career includes 14 years with the Bureau of Structural Evaluation in the former Division of Bridge Design, and 10 years in the Division of Project Management where he served as a Program Manager overseeing major statewide bridge projects and ultimately as Division Director. Under his leadership as Assistant Commissioner, the Department delivered record-breaking capital programs each fiscal year. 




