The meeting began at 9:30 am with Elise Bremer-Nei welcoming everyone and summarizing the agenda.

### Presentation by Jeremy Chrzan, PE, PTOE, LEED AP, Toole Design

# Navigating Updates to the Public Right-of-Way Accessibility Guidelines (PROWAG)

Jeremy Chrzan, PE, PTOE, LEED AP, from Toole Design discussed the U.S. Access Board's recently approved accessibility guidelines for the public right-of-way. Some of the highlights are:

- PROWAG is a set of guidelines produced by the U.S. Access Board under the Americans with
  Disabilities Act (ADA) and the Architectural Barriers Act (ABA) that address access to sidewalks
  and streets, crosswalks, curb ramps, pedestrian signals, on-street parking, and other
  components of the public right-of-way.
- New construction must fully comply with PROWAG except for pedestrian facilities used only by service personnel for maintenance, repair, or monitoring of equipment.
- Alteration projects must comply to the maximum extent feasible. Existing physical constraints
  may make compliance technically infeasible; however, existing right-of-way width is not a
  physical constraint.

- The updated PROWAG includes requirements for alternate pedestrian access routes, including the inclusion of audible or other non-visual signage in advance of decision points.
- Each crosswalk must have its own curb ramp, including an unmarked crosswalk. A single diagonal curb ramp is only permitted on a corner if two ramps are technically infeasible.
- Detectable warning surfaces are now required at driveway crossings with stop/yield control or traffic signals. They are not required on curb ramps used exclusively to provide access to onstreet parking and passenger loading zones.
- Multi-lane segments of roundabouts and multi-lane channelized turn lanes now require at least one of the following: a traffic control signal with a pedestrian head, pedestrian hybrid beacon, rectangular rapid flashing beacon, or raised crosswalk.
- Bollards are permitted to prevent motor vehicle entry into shared use paths, but there must be 4 feet between bollards.

Elise Bremer-Nei shared updates from the NJ Department of Transportation on the following topics:

## 1. NJDOT Vulnerable Road User Assessment

Under the Bipartisan Infrastructure Law, each State DOT was required to develop and publish a Vulnerable Road User Safety Assessment. Consistent with federal guidelines, New Jersey's VRU Assessment uses a data-driven process to identify areas of high risk and propose resulting safety strategies to improve safety in those areas. New Jersey's VRU Assessment is now available online. In addition, the Federal Highway Administration has created a single page with links to each State's report.

# 2. SS4A Grant Awards

As mentioned during the January BPAC meeting, the USDOT has announced its <u>full list of awardees</u> for the FY23 round of the Safe Streets and Roads for All (SS4A) competitive grant program. This includes a total of \$21.1 million in federal funding in this round for 23 communities across New Jersey. One implementation grant totaling \$14.4 million was awarded to the <u>Town of Hammonton for the Bellevue Avenue Safety Improvements Project</u>. Hammonton's 2021 local Bicycle and Pedestrian Planning Assistance study funded by NJDOT was used to help secure the grant. The SS4A project will address safety issues for pedestrians and bicyclists along a 1.3-mile stretch of Bellevue Avenue.

Applications for the FY24 SS4A program are now open and accessible on the <u>USDOT website</u>. There are three application deadlines for Planning and Demonstration Grants: April 4, May 16, and August 29, 2024. All Implementation Grant applications are due May 16, 2024.

# 4. New Jersey Bike & Walk Summit

Registration is now open for the 2024 NJ Bike & Walk Summit, which will be hosted by the New Jersey Bike & Walk Coalition on Saturday May 18th at Middlesex College, in Edison NJ. The NJ Safe Routes Academy will be a part of the live event. This summit is New Jersey's statewide meeting of bicycle and pedestrian advocates, elected officials and other local leaders, transportation engineers and urban planners, bike shop owners and managers, cycling, walking, fitness and health enthusiasts and experts, recreation, trails and club leaders and others who are interested in making our state a better place to live and be active.

NJBWC organized the state's first Bike & Walk Summit in 2010, when 25 people attended. Each year, the number of attendees has exceeded the year before. In 2017, 265 people participated. This year will be the first in-person summit since the COVID-19 pandemic.

## 5. New Jersey Sustainability Summit

Registration is also open for the 2024 New Jersey Sustainability Summit, which will be held on Friday, May 3 from 9:00 a.m. to 4:00 p.m. at the Bell Works in Holmdel. This one-day summit is hosted by Sustainable Jersey and highlights the successes and lessons learned from the people and projects that are helping New Jersey realize a more sustainable future. Summit attendees will walk away with tangible resources and strategies to assist with their own community initiatives. More information can be found on the Sustainable Jersey website.

# 6. NJDOT Local Bike-Ped Planning Assistance Updates

The New Jersey Department of Transportation and its on-call consultant teams have wrapped up a number of Bicycle and Pedestrian Planning Studies in recent months. In early March, the Borough of Clayton kicked off their project, and there are a couple of applications pending. The NJDOT <u>Bicycle and Pedestrian Planning Assistance Program</u> provides free planning assistance for towns who may be looking for help with bicycle and pedestrian mobility and safety issues, Complete Streets implementation or trail studies.

### 7. NJDOT SRTS Infrastructure Grant Program

Bill Riviere, NJDOT's Safe Routes to School Coordinator, has finished scoring all the SRTS Infrastructure Grant applications received by the Department and has met with the project selection committees. More information on these grants should be available in the coming weeks.

# 8. NJDOT Strategic Highway Safety Plan Updates

Priority Actions in the 2020 NJ Strategic Highway Safety Plan are wrapping up, and the Department is gearing up to develop the 2025 plan. The final report for the 2020 plan will be available on the NJ Strategic Highway Safety Plan website.

### 9. Sustainable Jersey Hero

The Sustainable Jersey program recognizes monthly heroes to capture the inspiring stories of local leaders. The Sustainability Hero for the month of March is VTC's **Leigh Ann Von Hagen.**
