Traffic lights are designed primarily for cars—but what if they could detect and prioritize waiting pedestrians without The need for tapping a push button? A project at Aston University in the U.K. uses a low-cost 360° camera and AI to do just that, aiming to improve traffic flow and pedestrian safety.

Developing Technology to Prevent Vehicles from Running Red Lights

Crashes that result from vehicles driving through red lights are often very serious because they are typically right-angle or side-impact crashes. While newer vehicles have many standard safety features such as lane departure warning and brake assistance systems to support drivers, they do not have technologies to help prevent driving through red lights. This project in Minnesota created an algorithm that uses traffic light data and GPS to alert drivers approaching a red light, enhancing safety and traffic efficiency.
